

ORDINANCE NO. 2026-10

AN ORDINANCE REQUESTING LOCAL APPROVAL FOR ALCOHOLIC BEVERAGE PERMITS FOR MILLWOOD CLUBHOUSE AND GOLF COURSE

Whereas, Millwood Clubhouse and Golf Course ("the Applicant") operates as a public golf facility within Little River County, Arkansas; and

Whereas, the Applicant seeks to obtain the appropriate alcoholic beverage permits through the Arkansas Alcoholic Beverage Control Division (ABC) for the sale and service of alcoholic beverages at the Clubhouse and Golf Course only; and

Whereas, Arkansas law requires acknowledgment or approval from the local governing body for certain alcoholic beverage permits; and

Whereas, authorizing the Applicant to obtain these permits will enhance guest experience, support tourism, and contribute to economic development within Little River County;

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF LITTLE RIVER COUNTY, ARKANSAS:

Section 1. Purpose.

The purpose of this ordinance is to formally request and authorize local approval for Millwood Clubhouse and Golf Course to apply for and obtain alcoholic beverage permits as required by the Arkansas Alcoholic Beverage Control Division.

Section 2. Authorization.

Millwood Clubhouse and Golf Course is hereby authorized and approved to apply for, obtain, and maintain the following alcoholic beverage permits for which it qualifies under Arkansas law:

- Retail Beer On-Premises Permit
- Retail Wine On-Premises Permit
- **Private Club Permit**
- Any additional restaurant-related or club-related ABC permits necessary for lawful alcohol service at the Clubhouse and Golf Course

Section 3. Business Location.

This authorization applies specifically to the premises known as:

The Applicant shall comply with all applicable federal, state, and local laws, regulations, and ABC rules governing the sale, service, and storage of alcoholic beverages.

Section 7. Severability.

If any section or portion of this ordinance is found invalid, the remaining sections shall remain in full force and effect.

Section 8. Effective Date.

This ordinance shall take effect on the 8th day of June, 2026.
